## **PRECAUTIONS**

### **KEEP OUT OF REACH OF CHILDREN.**

Avoid contact with eyes and skin. Causes painful stinging or burning of eyes and lids.

Prolonged contact with skin may cause irritation in some individuals. Wear chemical resistant gloves and face protection (face shield) when handling the concentrate. Do not eat, drink or smoke when using. Wash hands before meals and after work.

## **FIRST AID**

## **STORAGE**

Keep in original container tightly closed in a safe place when not in use. Store in a cool and dry location away from oxidizing and reducing agents. Keep away from heat, sparks and sources of ignition. Keep away from food, drink and animal feedstuffs.

## **SPILL CLEANUP**

Eliminate sources of ignition and ventilate area. Soak up spill with absorbent material (kitty litter, granular clay, earth) and collect into a waste container. Wash spill site with water after material pick-up and dispose with waste. See DISPOSAL statement below.

### **DISPOSAL OF UNUSED, UNWANTED PRODUCT:**

AGRAL 90 mixes with all types of water. The rate of AGRAL 90 is indicated for the control product spray mixtures or other uses listed below. Control product spray mixtures, their preparation and uses are to be derived from the individual labels for the control products.
